Morning Keynote Speaker – Colorado River Authority Utah representative; Zach Renstrom, Washington County Water Conservancy District; Stacy Young, SUHBA Government Affairs Director, as moderator.

Title - Liquid Lifelines: Navigating Water Challenges on the Colorado River

Colorado River Authority Utah representative, Amy I. Haas will discuss water, and the Colorado River followed by a Q&A Panel.



Bio – Amy I. Haas has been named the Colorado River Authority of Utah's (CRAU) first Executive Director. A longtime Colorado River veteran with 20 years of water management experience, Haas has held multiple positions specific to the Colorado River Basin. Most recently serving as Executive Director and Secretary of the Upper Colorado River Commission (UCRC), Haas became the first woman to do so in the organization's 73-year history. In this capacity, she saw that the Commission

fulfilled its statutory responsibilities under the 1948 Upper Colorado River Basin Compact, while supporting the water entitlements and obligations of the four Upper Division States (Colorado, New Mexico, Utah and Wyoming) under the 1922 Colorado River Compact. Haas also participated in negotiating and drafting the Upper Basin Drought Contingency Plan and related federal authorizing legislation. She represented the Upper Colorado River Basin on the U.S. delegation that drafted and is currently implementing a 2017 binational agreement (Minute 323) between the United States and Mexico for use of Colorado River water under the 1944 Mexican Water Treaty.

While at UCRC, Haas was also responsible for monitoring the implementation of the 2007 Colorado River Interim Guidelines for Lower Basin Shortages and the Coordinated Operations for Lakes Powell and Mead (2007 Interim Guidelines). She served as the liaison between the Upper Division States and Reclamation for the States' use of Upper Colorado River Basin Fund hydropower revenues. Additionally, Haas oversaw both the Upper Basin Consumptive Use Study to investigate potential adoption by the Commission of a uniform methodology for calculating Upper Basin consumptive uses, as well as updates to Upper Basin depletion demand schedules at regular intervals. Prior to joining UCRC staff, Haas was New Mexico's Upper Colorado River Commissioner and its Colorado River Basin States Representative from 2015-2017. She held these positions while working for the New Mexico Interstate Stream Commission as both Acting Director (2014-15) and General Counsel (2009-17). Named the 2017 Lawyer of the Year by the natural resources, energy and environment section of the New Mexico State Bar, Haas began her law career in New Mexico as an attorney in private practice, concentrating on water and land use law. A native of Northern California, Haas received a bachelor's degree from the University of California, Davis and a Juris Doctor from the University of New Mexico. When she's not working, Haas can be found trail running, hiking or doting on her two sons, the youngest of whom will be a freshman at the University of Utah in the fall of 2021.



Bio - **Zach Renstrom** is the general manager for the Washington County Water Conservancy District. In this capacity, he oversees all operational and financial activities for the district and its employees. Prior to joining the district in 2019, Renstrom served as a Washington County Commissioner, attorney and principal owner at a local engineering firm. He has more than 20 years of experience as an attorney and licensed professional and structural engineer. Renstrom has specialized in complex litigation on large infrastructure projects and intellectual property rights as an attorney; developed master plans, oversaw projects for the Utah Department of Transportation and served

as an expert witness as an engineer; and assisted in leading the county during massive growth while lowering the property tax rate as a county commissioner. His background gives him insight into the complexities of water treatment and engineering systems, as well as the legal realm of government, contracts, water law and legislation. He is a member of the Utah and Nevada state bars and has served on the following boards: Washington County Flood Control Authority, American Public Works Association, Dixie Transportation Executive Council, Colorado River Water Users Association, St George Area Economic Development Council, National Water Resources

Association, Utah Water Finance Agency, Utah Office of Tourism Development and the Tuacahn Center for the Arts. Renstrom is a graduate of the University of Utah and Washburn Law School.

Title - Energy Efficiency and Energy Code Updates for 2024

Know the Significant Changes to the Residential Energy Code
