

# WILL

- Must be probated
- Estate turned over to the legal system, chaos, long, expensive (Up to 10% of estate value)
- Estate becomes public - no privacy
- Can be challenged by anyone
- Costs must be paid before closing
- Capital Gains taxes (Approx 25%)
- Faces Federal Estate Tax (47%)
