**RV-11540 - 2020 NEC® Changes: General Requirements**

**Contact Hours: 1**

The National Electrical Code Style Manual has been in existence since 1969 and has been updated nine times since its inception. There was quite a bit of activity in the 2020 NEC® concerning definitions. In this interactive online course we will cover new definitions added, and existing definitions that have been revised or relocated in the 2020 NEC®. We will also review new and revised requirements for equipment installation, labeling, marking and working space.

- Recognize the revisions to under 1000 volt working space requirements in Sections 110.26(A)(3), 110.26(C)(2) and 110.26(D) and to over 1000 volt working space requirements in Sections 110.31(A)(4) and 110.32
- Explain new Section 110.12 Cables and Conductors and Section 110.21(A)(2) Reconditioned Equipment

**5. Proof of compliance with interactive distance learning requirements**

- a. Courses are being developed with interactivity as a key component in its development. RedVector's 'rule of thumb' is to insert an activity every 3 to 5 minutes or 500 to 800 words of text. The LMS will not allow a certificate to be issued or reflect course completion until the time requirement is met by the user.
- d. By one click of the button on each screen of the coursework, the user is given the option to obtain information in several ways.
