Work with IT on improving in-house computer systems for reporting and documentation of visits to customers.

Conduct noise monitoring, silica, dust, and various chemical exposure monitoring for various customers. Regular monitoring performed for specific customers. Consult with local AIHA certified laboratory to ensure valid sample results by using proper sample media and accepted OSHA and NIOSH sampling methods. Wrote reports to document exposure findings.
